Additional information:

All PoWs display the by the ETAP/ETAC Steering Board (SB) agreed on by ETAC to be delivered projects in the framework of ETAP and the intentions of Participants and 3rd parties to participate in a listed project. Hence, each PoW is a planning document serving solely for the indication of national interest regarding the offered various projects. The consideration of final Project Participants (PP) and the actual execution of projects is a matter of ETAC in coordination with the Receiving Participant (RP) and the SB. The status, which equals the release date, is to find in the lower left corner of each table.

The newly by DEU and FRA created bi-national C-130J wing 'BATS' is listed for practical reasons with a separate line. Required administrative agreements will be coordinated between DEU, FRA and ETAC.

Lithuania (LTU) being in the process to become Participant is listed as such already in PoW 23 in the strong believe that their accession to the Technical Arrangement (TA) will be concluded prior to the end of 2022.

The two (2) projects in Zaragoza (ETAP-C 23-1 and 23-4) are considered to be combined Day/Night projects. Priority will be given to nations intending to participate in both at the same time in the sense of better effectiveness as it is described in the ETAP/ETAC TA to be one of the main goal of ETAP.

Listed 3rd party nations (lower part of the table) are already authorised by the ETAP/ETAC SB to participate in projects, not yet listed 3rd parties require an unanimous decision by the ETAP/ETAC SB prior to be considered.

Generally valid for the considerations of 3rd parties in projects:
 Their application/participation must in principle not lead to the exclusion of any Participant to the ETAP/ETAC TA.
